2011/12 GTRNZ Race Series SANCTIONED SERIES AMENDMENT (Category Articles)

This amendment is issued under the provisions of the MotorSport NZ National Sporting Code Article 18 (2) in confirmation that the following amendments, notices or points of clarification have been authorised to the text of the Supplementary Regulations issued for the above named event. It is recommended that in addition to retaining a copy of this bulletin all parties modify the text of the regulations according to the following:

ITEM ONE

Article 3 Eligibility:

Amend Article 3.6 as follows:

3.6 CLASS STRUCTURE: There are three classes as follows;

- **GT1:** being cars which, in the opinion of the Club, qualify for the GT1 Class as capable of lap times (in dry conditions) as follows:
 - Pukekohe: 0'59.999 and under
 - Hampton Downs: 1'07.999 and under
 - Taupo: 1'31.999 and under
 - Manfeild: 1'09.999 and under

- **GT2:** being cars which, in the opinion of the Club, qualify for the GT2 Class as capable of lap times (in dry conditions) as follows:
 - Pukekohe: 1'00.000 and over
 - Hampton Downs: 1'08.000 and over
 - Taupo: 1'32.000 and over
 - Manfeild: 1'10.000 and over

- **NZGT:** being cars which, in the opinion of the Club, qualify for the NZGT Class as capable of lap times (in dry conditions) as follows:
 - Pukekohe: 1'04.600 and over
 - Hampton Downs: 1'12.900 and over
 - Taupo: 1'39.100 and over
 - Manfeild: 1'14.300 and over

Reason:

To amend the qualifying lap times due to circuit changes.

Article 10 Round Format:

Amend Article 10.3 as follows:
